Being located at one of the most strategic locations on the Gulf of Mexico is a huge asset in its own right, but the Venice Port Complex has much bigger plans for the future. We know that investing in infrastructure and technology is the key to the economic development of the Venice Port Complex and, for that matter, the whole of Plaquemines Parish. We are making progress at the moment as well as planning for an even

more prosperous future.
This begins with having a solid foundation to build on, exactly what we already have at the Venice Port Complex. Our strategic location affords us

with unique access to fishing, shipping, and oil and gas industry related business. Thus, we have attracted the presence of over 75 tenants and businesses. As the region gains recognition as an important hub for the energy industry, we see signs of improvement all around us.

One such improvement is the possibility of an airport. The Regional Planning Commission has approved the selection of GCR & Associates to conduct an airport study in Plaquemines Parish. The

Plaquemines Association of Business and Industry (PABI) airport committee believes that there is a need for an airport to service the west bank of Jefferson and Plaquemines. The only facility currently on the west bank is Southern Seaplane, which is a supporter of the study. Preliminary thoughts are that such a facility would help service the offshore expansion in the Eastern Gulf and fishing vessels of over 100 feet.

Results from the study should be received in 6 months. The cost of the study is being shared 50/50 by the state Department of Transportation and Development and

Plaquemines Parish. Regional Planning is facilitating at no cost.

More improvements can be seen in two vital projects – Tidewater Road and Baptiste Collette Bayou – that are taking off this spring and will undoubtedly benefit transportation at the Venice Port Complex.

Construction on Tidewater Road began in February and is scheduled to be completed next spring. Improvements will include the widening and raising of the road to an elevation of +5 feet (MSL) by Barriere Construction.

The Army Corps of Engineers announced in February that it will re-dredge Baptiste Collette Bayou this spring. The Corps will dredge the Bayou to a depth of 16 ft. About 1 million cubic yards of material will be dredged and used to create as much as 40 acres of wetlands on the west side of the bayou and 65 acres on the east side of the bayou on Shea Island, Plans for deeper dredging - up to 27 ft. are currently being studied. The feasibility study began in January of 2008 and scheduled to be complete by August of 2009. At that time the study will be presented to the Army Corps of Engineers for approval and funding.

The future is bright for the Venice Port Complex, and I look forward to seeing great progress over the next year. Please take the time to read more about some of the activities happening at the Port in this newsletter.

Drawing on a wealth of experience, Premier Industries Inc. conveniently meets the demands of fabrication and heavy lift by providing two work-flow efficient yards that are well equipped to handle even the most demanding project requirements. Located in Harvey on the Harvey Canal and at the Venice Port Complex, both locations offer intermediate and deep water Gulf of Mexico access by boat and barge and are outfitted with covered fabrication facilities, protected painting and blasting stations and heavy-lift cranes. In addition to these facilities, Premier has also secured an additional 520 feet of waterfront on 11 acres located adjacent to its Venice facility on Halliburton Road.

Premier's affiliated company, Louisiana Oilfield Divers (LOD), recently acquired a 4-Point Multi-Purpose Construction/Dive Support Vessel, M/V Premier Explorer, in response to market needs and client requests. This will allow Premier and LOD to further serve their customers' needs through Premier Industries and LOD's Top to Bottom turnkey approach to business services.

The M/V Premier Explorer is a United States Flag Vessel with International Class: (ABS, Solas, ISSC ship security certificate, ISM Compliant) and a Port of Registry in Venice. The M/V Premier Explorer measures 208 ft. x 53 ft. x 13.5 ft. with 2,140 horsepower uniquely configured to accommodate 44 persons, ample storage, a fully functional machine shop, multiple working



decks, shallow and intermediate diving capabilities, 3 dive chambers and a 45-ton crane. Upon completion, which is scheduled for the end of the first guarter 2008, the Premier Explorer will be relocated to the vessel's homeport of Venice.

Premier's Venice Facility offers a 14-acre yard with 800 feet of steel bulkhead and an 18-foot water depth. Current projects out of the Venice offshore area include facility upgrades, compressor removals and installations, pipeline and platform P&A's, pipeline installations, marine construction, platform upgrades, diving services and Hurricane Katrinarelated projects.
